

HPM x Benjamin Moore 10 Gallon Paint Giveaway Official Rules

Eligibility: The Giveaway is open only to legal Hawai'i Island residents who are 18 years of age or older at time of entry. Owner employees and immediate family members of HPM Building Supply are not eligible to enter. The Giveaway is subject to all federal, state and local laws and regulations and is void where prohibited by law.

Agreement to Official Rules: By participating in the Benjamin Moore Vendor Spotlight Giveaway, participants fully and unconditionally agree to and accept these Official Rules and the decisions of the Sponsors, which are final and binding in all matters related to the Giveaway. Sponsors have the right to revise Official Rules as necessary.

Giveaway Period: Entries will be collected in person on Wednesday, September 2, 2026 at the Benjamin Moore booth during vendor spotlight visits at the following HPM store locations and times:

Hilo: 8:00 AM to 10:00 AM

Waimea: 12:00 PM to 1:00 PM

Kona: 2:30 PM to 4:30 PM

How to Enter:

Customers may enter to win by filling out a paper entry form in person at the Benjamin Moore booth at their local HPM store during the vendor spotlight visit listed above. Entrants must be present at the booth to sign up and may enter only at the store location where they are present. Limit one entry per person per store visit.

Prize: One winner per store location (Hilo, Waimea, and Kona) will each win one free 10 gallon Benjamin Moore paint.

Giveaway Winner Selection and Verification: One winner per store will be randomly selected from among that store's eligible entries on Thursday, September 3, 2026. Winners will be contacted directly by HPM staff using the contact information provided on their entry form. If a winner cannot be reached or does not respond within a reasonable time, Sponsors reserve the right to randomly select an alternate winner from the same store's entries.

The Winner's Responsibility: There are no substitutions, exchanges, or transfers of the Prize by Winner. Winner is responsible for all taxes and fees associated with the Prize. Winner must redeem the Prize by purchasing their free 10 gallon Benjamin Moore paint at their winning HPM store location no later than December 18, 2026. Prizes not redeemed by this date will be forfeited. The Winner will need to present photo identification at the time of redemption.

Publicity: Except where prohibited, participation in the Giveaway constitutes the entrant's consent for Sponsors to use the Winner's name and photo for promotional purposes in any media without further consent. A media release form will be presented along with the winner verification form.

General Conditions: In the event that the operation, security, or administration of the Promotion is impaired for any reason, including but not limited to fraud, technical failures, regularly scheduled maintenance, or other problems, the Sponsor may, in its sole discretion, either suspend the Promotion and award the prize in a random drawing from among all eligible entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the

Promotion, or to be acting in violation of the Official Rules, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Release and Limitations of Liability: Except where prohibited, by participating in the Promotion, entrants agree to release and hold harmless HPM Building Supply and Benjamin Moore, and their affiliates, promotional partners, prize partners, agents and agencies and the officers, directors and employees of each of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Promotion or receipt or use of any prize, including but not limited to unauthorized human intervention in the Promotion, technical errors, printing errors, errors in the administration or processing of entries, late, lost, or undeliverable entries, or injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the entrant's participation in the Promotion or receipt of any prize. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Promotion, and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including but not limited to punitive, consequential, direct, or indirect damages. If, for any reason, an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry form.

Disputes: Entrant agrees that any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States Hawaii County Court of the Island of Hawaii or the appropriate Hawaii State Court located in Hawaii Island County, Hawaii. Any and all claims, judgements and awards shall be limited to actual out of pocket costs incurred, including costs associated with entering the Promotion, but in no event attorney's fees. All issues and questions concerning the construction, validity, interpretation and enforcement of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Promotion, shall be governed by and construed in accordance with the laws of the State of Hawaii, without giving effect to any choice of law rules (whether of the State of Hawaii or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Hawaii.
